Admission will be held for H.S. 2nd Year students from 17-08-2023 to 27-08-2023 at Tezpur College. Those students who have appeared/ Filled up examination form in H.S. 1st year examinations are eligible to take admission in the H.S. 2nd year as per AHSEC notification.

All are instructed to take admission by log-in the portal tezpuroonline.co.in (select the Student Portal option) and to fillup the forms and upload all required data properly and to take a printout of the uploaded form and to submit the same at the College office for verification and fee allocation.

1. Proof of H.S. 1st year Exam. Appeared/ Form filled up documents.
2. Fee waived scheme will be applicable only for the Arts stream students after fulfillment of the Fee waived terms and condition.
3. Parents' Annual Income Certificate issued by local Revenue Circle officer and as per Govt. notification no. 490303/2024/9.
4. Students whose parent's annual income is less than Rs. 2.00 lakh from all source will be eligible to avail this scheme.
5. If either of the parent (mother or father) of the student is working in the State Govt./ Central Govt./ Semi Govt./ State or Central Govt. undertaking, such students shall not be eligible under this scheme.
6. Fee waived scheme is only for regular students having minimum 75% of attendance in classes.
7. The photograph of the plant sapling which was provided/submitted at the previous time, for availing free admission same plant photograph with a proof of growth of the same to be submitted to the College for availing the fees waived scheme.
8. The Students of H.S. 2nd year must submit the Unique ID allotted by the Director of Higher Education and upload the same.
9. A declaration from the students that neither of the parents (father or mother) of the student is an employee of State/ Central Govt. Department or its undertaking. Such form shall be provided by the college. If the declaration is found to be false, the admission shall be cancelled and fee shall be realized from such students.

The admission Committee of the concerned College shall have the power to enquire into the income of the family and the photograph of the sapling in case of doubt and to cancel the same.
